- At this time LCS continues to have had one student and one staff member with confirmed COVID-19. Neither obtained the virus at school or is known to have spread the virus at school.
- Staff is currently feeling increased stress as case counts in the community rise. Leadership is exploring options to provide additional support and options to cope with high stress.
- As public school community schools make decision to move to virtual or not, they must make the decision as a district. LCS continues to monitor all information and is making decisions that is right for the LCS school community.
  - As other schools move to virtual, we are seeing an increased interest in Lourdes enrollments by families that want their students be in an in person instructional environment rather than virtual.
