## 7) Old Business or New Business

- Road Construction Update: Brent Morlock - City of Bettendorf Engineer
- Bridge update - East span of bridge will be open to traffic by end of the year. Approximately Thanksgiving it will open for West bound traffic, 3-4 weeks later for East bound. Two lanes of traffic will travel in each direction.
- 14th St./Brown project - Some delays have been experienced following the storm. Project should be completed second week of October.
- Last Iowa exit (Grant Street exit) remains closed - detour exiting I-74 onto Kimberly Rd./Middle Rd. exit will remain in place until approximately November 1
- 18th St. reconstruction - Project is planned to be completed approximately the 2 nd week of October.


## 8) Father Jason Crossen Report

- Bettendorf Vision - Monday was first public Zoom information meeting, approximately 100 in attendance. Next meeting on Tuesday Sept. 22 at 6:30 PM. All welcome to participate. Working to gather community feedback on information gathered and proposed scenarios.
- Brian Nikulski. commented that he was very pleased with involvement of parishioners and the open mindedness of all involved to view the big picture. Tom Melchert echoed those thoughts.
- Parish Council president Cathy Halter has resigned. Nominations in place to fill open positions and identify a replacement for president.
- Offertory has been declining over past few months with COVID-19, parish team is working to explore opportunities to communicate the continued need of offertory to maintain parish function and activities.
- First Communion complete and most confirmations are complete.

9) Principal Report - see report

- Through Bettendorf schools LCS has $\$ 13,000$ of title money that must be spent by June 30. Exploring options to use towards math specialist.
- So far, no cases of COVID in the school, students and staff following guidelines.
- Tom M. asked about tracking of absenteeism; Jennifer explained schools are required to track any absences due to COVID related symptoms (not only when positive). The information is needed to report on percentage of absences.
- Mark M. asked about status of the new playground equipment purchase and installation from Starry Night funds. Some delays occurred obtaining required with approvals to install, deposit has now been made and project is moving forward.

- August received $\$ 5500$ of donations mostly to be used to purchase PPE for school.
- Accounts receivable is currently higher than normal, payments from families are coming in slower than normal.
- Megan Stopulos commented that this issue was also raised during the H\&S meeting. Some families appear to be confused on what is owed and without the in person unpack the backpack night several families don't have regular payments set-up and have not made payment of initial fees. Ms. Alongi is working with Katie Carrol on communication to clear up.
