ELECTRONIC DEVICES

We have been seeing a growing problem in the classroom. Smart watch technology has been increasing in a way that is distracting to our students. The use of phones, smart watches, and other electronic devices are part of the handbook. The following is the policy:

a. Cell phones/electronic devices are not permitted in class. Students may not use phones and devices to take photographs. If a student is discovered to have a cell phone/electronic device in his or her possession without express teacher permission, it will be taken and kept in the Principal's office until the end of the school day. The student may retrieve it after dismissal. If the device is taken a second time, it will remain in the Principal's office until the student's parent or guardian comes to pick it up.

Smart watches, such as Apple watches, fall under this plan. It has also been discussed in many classrooms with the students this week. There are many questions that the kids have raised regarding their own types of watches. In general, if they are capable of messaging, texting, receiving calls, etc., they will not be allowed. If a student does bring one to school, it should be treated in the same manner as a cellphone, silenced and in the back pack. We understand that this may be an inconvenience, but protecting our students' time and educational experience are our priority. The principal will make the final decision regarding specific devices.

Educational Savings Accounts (ESAs)

The "Student First Act" passed the legislature and was signed into law by Governor Reynolds. The following is a general summary of the bill:

Education Savings Accounts

Parents who choose to enroll their children in an accredited private school will receive the amount of per pupil funds allocated annually by the state to use for tuition, fees, and other qualified expenses. Funds are deposited into an education savings account (ESA) each year until students graduate or complete high school or turn 20 years of age. Educational Savings Accounts will be phased in over three years.

Effective for the 2023-24 school year, state per pupil funding will be \$7,598 per student, and ESAs will be available based on the following eligibility:

Year 1: School Year 2023-24

- All kindergarten students
- All students who were not in a non-public school the year prior
- Private school students with a household income at or below 300% Federal Poverty Level (FPL), currently at about about \$83,250 for a family of four but subject to change

Year 2: School Year 2024-25

- All kindergarten students (and first graders)
- All students who were not in a non-public school the year prior
- Private school students with a household income at or below 400% FPL, currently about \$111,000 for a family of four but subject to change

Year 3: School Year 2025-26

All K-12 students in lowa regardless of income

Other student funding generated by categorical funding formulas will remain with public school districts even for students who are not attending public schools any more. This amount is about \$1,202 per pupil for each student who will be attending a private school.

Next steps include the writing of the Administrative Rules at the state level and the development of processes to then be used in Scott County Catholic Schools. As you can imagine, there is a lot of work being done rapidly as enrollment processes for 2023-24 are set to begin sometime in February.
